A RESOLUTION OF THE BOARD OF SUPERVISORS OF DICKINSON TOWNSHIP, CUMBERLAND COUNTY, PENNSYLVANIA, ADOPTING THE CUMBERLAND COUNTY 2014 HAZARD MITIGATION PLAN

WHEREAS, Dickinson Township is vulnerable to natural and human-made hazards which may result in loss of life and property, economic hardship, and threats to public health and safety; and

WHEREAS, the Disaster Mitigation Act of 2000 (Act), P.L. 106-390, October 30, 2000, 52 U.S.C. 5121, et seq., provides for planning and procedures for disasters; and

WHEREAS, Section 322 of the Act requires that a municipality submit to the President a mitigation plan that outlines processes for identifying the natural hazards, risks, and vulnerabilities of the area under the jurisdiction of the municipality as a condition of receipt of receipt of federal hazard mitigation and disaster funds and loans; and

WHEREAS, the Cumberland County 2014 Hazard Mitigation Plan has been developed by the Cumberland County Emergency Management Agency in cooperation with other county departments and officials; and

WHEREAS, Cumberland County conducted a public involvement process consistent with the requirements of the Act for the development of the 2014 Hazard Mitigation Plan; and

WHEREAS, the 2014 Hazard Mitigation Plan recommends mitigation activities that will reduce losses to life and property affected by both natural and human-made hazards that the Township may face; and

WHEREAS, the Township's Emergency Management Coordinator has reviewed and recommends that the Board of Supervisors adopt the 2014 Hazard Mitigation Plan as the Township's official Hazard Mitigation Plan.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF DICKINSON TOWNSHIP:

- 1. The 2014 Hazard Mitigation Plan is hereby adopted as the official Hazard Mitigation Plan of Dickinson Township.
- 2. The respective officials and agencies identified in the implementation strategy of the 2014 Hazard Mitigation Plan are hereby authorized to implement the recommended activities assigned to them.
