### CALL TO ORDER

**FINANCIAL STATUS-** The Parks & Recreation Fund account balance is \$49,054.81. There is a bill for Lindenwood Park grass seed for \$292.38, but it will come from the General Fund.

### NEW BUSINESS

1. **New Candidate:** Adam Felix introduced himself and expressed interest in joining the Parks & Recreation Board.
2. **Land Partnership Grant Project(s):** More Land Partnership Grants are available. September 25<sup>th</sup> 2015 is the deadline. \$100,000 in funding will be available for competitive grants. This funding is derived from the Act 13 Marcellus Shale Legacy Fund. Some possible projects discussed: Stuart Park restrooms and Lindenwood Park bike racks. Discussion on possible use for grant(s) is ongoing until the next meeting.

### OLD BUSINESS


1. **Ice Cream Social:** The Ice Cream Social was deemed a success with 300 attending.
