## PARKS & RECREATION MEETING NOVEMBER 24, 2014

### CALL TO ORDER

**APPROVAL OF MINUTES** – A motion was made by Beth Kikla to approve the October 27, 2014 minutes with the following correction:

The Township is receiving invoices for 2A stone for the trail at Lindenwood Park. The 2013 original budget was for \$4.75/ton. However, the 2014 price is currently \$5.30/ton. Larry is working to contain costs. The design has been submitted to excavators to submit bids.
