Lloyd and Joy Hair expressed their concern with the neighbor placing snow from his property across Walnut Bottom Road onto Mr. Hair's property, as well as blowing leaves across the road and with the USPS mailbox placement on Mr. Hair's side of the road and unwanted mail being left behind on his property. Mr. Hair has spoken with State Police and the Post Office, with no satisfaction. He requested the Township add a good neighbor clause to the existing Nuisance Ordinance. Codes Enforcement Officer Kelso said a letter will be sent to the neighbor with regard to placing snow in the road right-of-way and if the neighbor continues to do so a violation can be filed with the District Justice who determines fines, if any. If the snow is placed outside the

road right-of-way, it is a civil matter between the two parties involved. Vice Chairman Line thanked the Hairs for attending the meeting and expressing their concerns. The Township strives to defuse matters of this nature and hopefully the letter will be helpful.
