

A Note from the Manager

Dickinson Township residents will notice, or have noticed a newly adopted .75 mill (0.00075) general real estate tax on their tax bills for 2023. After several public meetings were held between the months of October through December of 2022, and with a significant amount of public input, the Board of Supervisors levied the tax. To assist you in calculating the new tax cost, you must determine your assessed value of your home/ property which can be found at the top of your tax bill. The Fire Tax portion of the tax bill has been in place for over ten years.

The tax will generate a steady income to offset inflation costs and allow for continued road work, payroll, park and recreation development, snow removal equipment and supplies, and overall continued maintenance and services to keep up with the steady growth of the Town-





As per Dickinson Township Zoning Ordinance Chapter 205-22A: Corner Lots: No obstruction to vision exceeding 30" in height above street level shall be erected or maintained within a 100' clear sight triangle formed by the centerline of intersecting streets. Due to safety concerns this could cause when pulling out of intersections, this Ordinance will be enforced.

Cumberland County Vector Control is Gearing up for another year

As the winter months wind down, Cumberland County Vector Control is gearing up for the 2023 West Nile and Tick Seasons. The spring so far has been very wet, making it easy to see where water is laying. It's a good time to prepare yourselves for the warmer weather by clearing your yard of any standing water; this includes any buckets, toys, or rain barrels that could be holding water for more than a week.

You should also get a repellent that you feel comfortable with using, and wear longer sleeved clothes that are lighter in color when possible. This will help stop mosquito bites on your arms, as

well as help with finding any ticks that try to catch a ride on your clothing.

It is also a good time to clear any thin or remove any thicker bushes or leaf piles you may have a round your yard. Mosquitoes love to hang out in thicker, shade vegetation like ivy or shrubs, and ticks love to stay in the leaf litter that piles up on the ground.
