PARKS & RECREATION BOARD MEETING
July 22, 2024

CALL TO ORDER

NEW BUSINESS

The Board suggested placing security cameras at Stuart Park parking lot area and pavilion to see the activity that occurs, especially after dark. The installation of a motion light or dusk to dawn light were also suggested.

3. Park Upgrades

The Board suggested a flag be installed at Lindenwood Park, and the possibility of using solar lighting. They also suggested installing a sign at Lindenwood Park. They questioned the status of the sign installation at Stuart Park and suggested looking into getting assistance from the area vo-tech schools or the scouts to get the project completed.

The Board members expressed their interest in recommending Diane Gill be appointed to the Park & Recreation Board. Chairwoman Quigley will contact Ms. Gill to see if she is still interested.

2. 2025 Budget
