**RESOLUTION NO. 2025-03**

**A RESOLUTION OF THE TOWNSHIP OF DICKINSON, CUMBERLAND COUNTY,  
PENNSYLVANIA, AUTHORIZING ITS TAX COLLECTOR TO CHARGE FEES FOR  
CERTAIN TASKS AND FIXING THOSE FEES**

**WHEREAS**, the Township of Dickinson, Cumberland County, Pennsylvania (the "Township"), is a municipal corporation organized and existing under the laws of the Commonwealth of Pennsylvania; and

**WHEREAS**, the duly elected Tax Collector of the Township is compensated pursuant to the Local Tax Collection Law, 72 P.S. § 5511.35; and

**WHEREAS**, the Local Tax Collection Law authorizes the Township to authorize by resolution fees for certain ancillary tasks performed by its Tax collector unrelated to the levy or collection of the tax; and

**WHEREAS**, the Township Tax Collector has asked the Board of Supervisors to authorize such fees and the Board of Supervisors believe that such fees are appropriate and proper.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Supervisors of Dickinson Township, Cumberland County, Pennsylvania, as follows:

**SECTION 1.** The above recitals are incorporated herein by reference thereto and made a part of this Resolution.

**SECTION 2.** The Tax Collector of Dickinson Township, Cumberland County, Pennsylvania, is authorized to provide tax certifications, copies, and receipts upon request by the public.

**SECTION 3.** The Tax Collector is further authorized to assess, collect, and retain fees in the following amounts as compensation for such additional service. These fees may be changed from time to time by resolution of the Board of Supervisors in accordance with the law.

Returned Check Fee:	\$30.00
Tax Certification	20.00
Duplicate Tax Bill:	2.00

**SECTION 4.** All provisions of previous resolutions or ordinances which are contrary to this Resolution are expressly repealed.

**SECTION 5.** If any sentence, clause, section, or part of this Resolution is for any reason found unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts hereof. It is hereby declared the intent of the Board of Supervisors of the Township of Dickinson that this Resolution would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, section, or part thereof not been included therein.

**SECTION 6.** This Resolution shall take effect immediately.

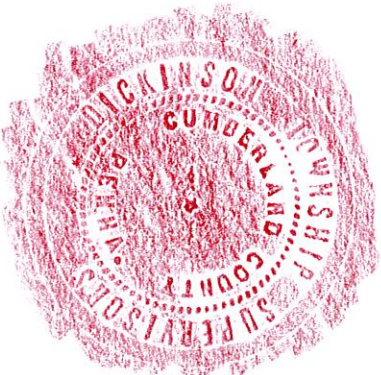


