**A RESOLUTION OF THE TOWNSHIP OF DICKINSON, CUMBERLAND
COUNTY, PENNSYLVANIA, APPOINTING MEMBERS TO THE
DICKINSON TOWNSHIP ENVIRONMENTAL ADVISORY
COMMITTEE**

WHEREAS, Dickinson Township (the “Township”) is a municipal corporation organized and existing under the laws of the Commonwealth of Pennsylvania; and

WHEREAS, the Township Board of Supervisors enacted Ordinance 2025-02 establishing a Township Environmental Advisory Committee (the “EAC”) pursuant to 53 Pa.C.S. § 2322; and

WHEREAS, the Board of Supervisors has the authority to appoint the members and designate the chairperson of the EAC pursuant to 53 Pa.C.S. § 2323; and

WHEREAS, the Board of Supervisors deems it beneficial to the Township and desires to appoint three members of the EAC through this Resolution.

NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the Township of Dickinson, Cumberland County, Pennsylvania as follows:

Section 1. The above recitals are incorporated herein by reference hereto.

Section 2. The Township hereby appoints the following residents to serve as members of the Township’s Environmental Advisory Council for the terms as follows and consistent with all other provisions of the Second Class Township Code, 53 Pa.C.S. §§ 2321, *et seq.*, and any related Dickinson Township ordinances:

Jared Abell – term expiring December 31, 2026

Jen DeGaetano – term expiring December 31, 2027

Nate Merkel – term expiring December 31, 2028

Section 3. Nate Merkel is hereby appointed as chairperson of the Environmental Advisory Committee.

Section 4. The provisions of this Resolution shall be severable, and if any of its provisions shall be held unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect the validity of any of the remaining provisions of this resolution.


Section 5. All resolutions, or parts thereof, insofar as they are inconsistent herewith, shall be hereby repealed.
