**A RESOLUTION OF THE TOWNSHIP OF DICKINSON, CUMBERLAND
COUNTY, PENNSYLVANIA, APPOINTING AN AUDITOR TO FILL A
VACANCY**

WHEREAS, Dickinson Township (the “Township”) is governed by Pennsylvania’s Second Class Township Code, 53 P.S. § 65101, *et seq.* (the “Code”); and

WHEREAS, the Code empowers the Township to enact, revise, repeal, and amend ordinances and resolutions, not inconsistent with the laws of the Commonwealth, as it deems beneficial, and to provide for enforcement of the same; and

WHEREAS, Section 402 the Code, 53 P.S. § 65402, requires the electors of the Township to elect three auditors; and

WHEREAS, there is currently an auditor vacancy in the Township; and

WHEREAS, the Board of Supervisors has the authority to fill auditor vacancies pursuant to Section 407 of the Code, 53 P.S. § 65407; and

WHEREAS, the Board of Supervisors deems it beneficial to the Township and desires to appoint an auditor through this Resolution to fill said vacancy.

NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the Township of Dickinson, Cumberland County, Pennsylvania as follows:

Section 1. The above recitals are incorporated herein by reference hereto.

Section 2. The Township hereby appoints the following resident to serve as an auditor of the Township for the term as follows and consistent with all other provisions of the Second Class Township Code and any related Dickinson Township ordinances:

Janet Kemp – term expiring January 3, 2028


Section 3. The provisions of this Resolution shall be severable, and if any of its provisions shall be held unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect the validity of any of the remaining provisions of this resolution.

Section 4. All resolutions, or parts thereof, insofar as they are inconsistent herewith, shall be hereby repealed.

Section 5. This Resolution shall become effective immediately.


