**RESOLUTION NO. 2026-12**

**A RESOLUTION OF THE TOWNSHIP OF DICKINSON, CUMBERLAND  
COUNTY, PENNSYLVANIA, APPOINTING A MEMBER TO FILL A  
VACANCY ON THE PARKS & RECREATION COMMITTEE**

**WHEREAS**, Dickinson Township (the “Township”) is governed by Pennsylvania’s Second Class Township Code, 53 P.S. § 65101, *et seq.* (the “Code”); and

**WHEREAS**, the Code empowers the Township to enact, revise, repeal, and amend ordinances and resolutions, not inconsistent with the laws of the Commonwealth, as it deems beneficial, and to provide for enforcement of the same; and

**WHEREAS**, Section 2204 of the Code, 53 P.S. § 67204, requires that the Parks & Recreation Committee be comprised of five, seven, or nine persons who are appointed by the Board of Supervisors; and

**WHEREAS**, there is currently a vacancy on the Parks & Recreation Committee; and

**WHEREAS**, the Board of Supervisors has the authority to fill vacancies pursuant to Section 2204 of the Code, 53 P.S. § 67207; and

**WHEREAS**, the Board of Supervisors deems it beneficial to the Township and desires to appoint a resident to the Parks & Recreation Committee through this Resolution to fill said vacancy.

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Supervisors of the Township of Dickinson, Cumberland County, Pennsylvania as follows:

Section 1. The above recitals are incorporated herein by reference hereto.

Section 2. The Township hereby appoints the following person to serve as a Parks & Recreation Committee member of the Township for the term as follows and consistent with all other provisions of the Second Class Township Code and any related Dickinson Township ordinances:

Sally McClintock – term expiring December 31, 2030 serving a 5-year term

Section 3. The provisions of this Resolution shall be severable, and if any of its provisions shall be held unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect the validity of any of the remaining provisions of this resolution.


Section 4. All resolutions, or parts thereof, insofar as they are inconsistent herewith, shall be hereby repealed.


Section 5. This Resolution shall become effective immediately.






