RESOLUTION NO. 2026-13

A RESOLUTION OF THE TOWNSHIP OF DICKINSON, CUMBERLAND COUNTY, PENNSYLVANIA, AUTHORIZING THE REQUEST FOR A GREENWAYS, TRAILS, AND RECREATION PROGRAM GRANT OF UP TO \$250,000.00 FROM DEPARTMENT OF COMMUNITY & ECONOMIC DEVELOPMENT (DCED) FOR STUART PARK IMPROVEMENTS AND DESIGNATING ROB KOLE, CHAIRMAN OF THE BOARD OF SUPERVISORS, AND JILL LOVETT, TOWNSHIP MANAGER, AS THE OFFICIALS TO EXECUTE ALL DOCUMENTS AND ASSIST IN OBTAINING THE GRANT

WHEREAS, Dickinson Township, Cumberland County, Pennsylvania (the “Township” or “Applicant”) desires to improve Stuart Park with improvements in the Township (the “Stuart Park Improvements items”); and

WHEREAS, the Township has identified the Greenways, Trails, and Recreation Program Grant as a potential source of funding for these improvements for Stuart Park; and

WHEREAS, the Township has determined that said potential funding would promote the health, safety and welfare of the local community, and therefore the Township supports a grant application.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of Dickinson Township, that the Applicant hereby requests a Greenways, Trails, and Recreation Program Grant of up to \$250,000.00 from the Department of Community & Economic Development to be used for the Stuart Park Improvement Project, including the pavement of trails, adding trails, cement maintenance to the pavilion, adding park signage, picnic tables, camera security and paving the existing parking area for recreational use.

BE IT FURTHER RESOLVED, that the Applicant agrees to the “Terms and Conditions of Grant” included with the application package; also including the requirement of the grant for a 15% cash or non-cash match.

BE IT FURTHER RESOLVED, that the Applicant does hereby designate Rob Kole, Chairman of the Board of Supervisors, and Jill Lovett, Township Manager, as the officials to execute all documents and agreements between the Township and the Department of Conservation and Natural Resources to facilitate and assist in obtaining the requested grant.

DULY ADOPTED, pursuant to the authority granted to the Township of Dickinson under the laws of the Commonwealth of Pennsylvania in lawful session duly assembled on this 6th day of May 2026.


