**A RESOLUTION OF THE TOWNSHIP OF DICKINSON, CUMBERLAND
COUNTY, PENNSYLVANIA, APPOINTING A NEW CHAIRPERSON
AND A MEMBER TO FILL A VACANCY ON THE DICKINSON
TOWNSHIP ENVIRONMENTAL ADVISORY COUNCIL**

WHEREAS, Dickinson Township (the “Township”) is a municipal corporation organized and existing under the laws of the Commonwealth of Pennsylvania; and

WHEREAS, the Township Board of Supervisors enacted Ordinance 2025-02 establishing a Township Environmental Advisory Council (the “EAC”) pursuant to 53 Pa.C.S. § 2322; and

WHEREAS, the Board of Supervisors has the authority to appoint the members and designate the chairperson of the EAC pursuant to 53 Pa.C.S. § 2323; and

WHEREAS, there is currently a member and chairperson vacancy on the EAC; and

WHEREAS, the Board of Supervisors has the authority to fill vacancies on the EAC pursuant to 53 Pa.C.S. § 2323; and

WHEREAS, the Board of Supervisors deems it beneficial to the Township and desires to appoint a new member of the EAC and to designate a new chairperson through this Resolution to fill said vacancy.

NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the Township of Dickinson, Cumberland County, Pennsylvania as follows:

Section 1. The above recitals are incorporated herein by reference hereto.

Section 2. The Township hereby appoints the following resident to serve as a member of the Township’s Environmental Advisory Council for the term as follows and consistent with all other provisions of the Second Class Township Code, 53 Pa.C.S. §§ 2321, *et seq.*, and any related Dickinson Township ordinances:

Mark Hockley – term expiring December 31, 2028

Section 3. Jared Abell is hereby appointed as Chairperson of the Environmental Advisory Council.

Section 4. The provisions of this Resolution shall be severable, and if any of its provisions shall be held unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect the validity of any of the remaining provisions of this resolution.

Section 5. All resolutions, or parts thereof, insofar as they are inconsistent herewith, shall be hereby repealed.

Section 6. This Resolution shall become effective immediately.




