**A RESOLUTION OF THE TOWNSHIP OF DICKINSON, CUMBERLAND COUNTY, PENNSYLVANIA, FORMALLY REQUESTING A CATEGORY 4 FACILITIES LOCAL SHARE ASSESSMENT GRANT OF \$200,000.00 FROM THE COMMONWEALTH FINANCING AUTHORITY FOR THE LINDENWOOD PARK IMPROVEMENT PROJECT AND DESIGNATING ROB KOLE, CHAIRMAN OF THE BOARD OF SUPERVISORS, AND JILL LOVETT, TOWNSHIP MANAGER, AS THE OFFICIALS TO EXECUTE ALL DOCUMENTS AND ASSIST IN OBTAINING THE GRANT**

**WHEREAS**, Dickinson Township, Cumberland County, Pennsylvania (the "Township" or "Applicant") desires to improve Lindenwood Park in the Township (the "Lindenwood Park Improvement Project"); and

**WHEREAS**, the Township has identified the Category 4 Facilities Local Share Assessment Grant as a potential source of funding for the Lindenwood Park Improvement Project.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Supervisors of Dickinson Township, that the Applicant hereby requests a Category 4 Facilities Local Share Assessment grant of \$200,000.00 from the Commonwealth Financing Authority to be used for the Lindenwood Park Improvement Project Phase I, including the installation of water, septic, electric, stormwater, and lighting infrastructure.

**BE IT FURTHER RESOLVED**, that the Applicant does hereby designate Rob Kole, Chairman of the Board of Supervisors, and Jill Lovett, Township Manager, as the officials to execute all documents and agreements between the Township and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.

**DULY ADOPTED**, pursuant to the authority granted to the Township of Dickinson under the laws of the Commonwealth of Pennsylvania in lawful session duly assembled on this 2nd day of September 2026.

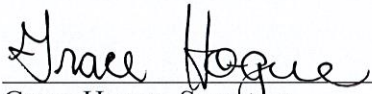
